ORDINANCE #848

AN ORDINANCE RELATING TO THE ANNUAL APPROPRIATION FOR THE TOWN OF HUDSON, WYOMING AND FURTHER RELATING TO FIXING AND DETERMINING THE AMOUNTS OF GENERAL TAX TO BE LEVIED TO MEET THE CURRENT EXPENSES OF SAID TOWN FOR THE FISCAL YEAR BEGINNING ON THE 1ST DAY OF JULY 2018 AND ENDING AT MIDNIGHT ON THE 30TH DAY OF JUNE 2019, AND PROVIDING FOR AN EFFECTIVE DATE.

Section 1. The following sums of money for the objects and purposes herein specified which are deemed necessary to defray expenses and liability for the Town of Hudson, for the period July 1, 2018 through June 30, 2019.


